Healthcare for Adults with Developmental Disabilities

The WITH Foundation is inviting letters of intent from organizations for efforts to promote comprehensive health care for adults with developmental disabilities. **Grants, ranging from \$30,000-50,000 for 1 to 3 years, will be awarded.** A broad range of topics are of interest, including improving health practitioner competency through education and/or training programs; care coordination; social policy research; and identifying and overcoming barriers to high-quality healthcare access, among others. Dear Colleague Letters on COVID-19; also on Robotics

- **COVID-19:** The National Science Foundation is accepting proposals to **conduct non-medical, non-clinical-care research that can be used immediately to explore how to model and understand the spread of COVID-19**, to inform and educate about the science of virus transmission and prevention, and to encourage the development of processes and actions to address this global challenge.

NSF encourages the research community to respond to this challenge through existing funding opportunities. In addition, they invite researchers to use the Rapid Response Research (RAPID) funding mechanism, which allows NSF to receive and review proposals having a severe urgency with regard to availability of or access to data, facilities or specialized equipment as well as quick-response research on natural or anthropogenic disasters and similar unanticipated events. - **Foundational Research in Robotics:** The National Science Foundation announces the creation of the Foundational Research in Robotics (Robotics) program as a program jointly managed by the Directorates for Engineering (ENG) and Computer and Information Science and Engineering (CISE). **The goal of the Robotics program is to erase artificial disciplinary boundaries and provide a single home for foundational research in robotics.** Starting August 1, 2020, the Robotics program will accept unsolicited proposals at any time. 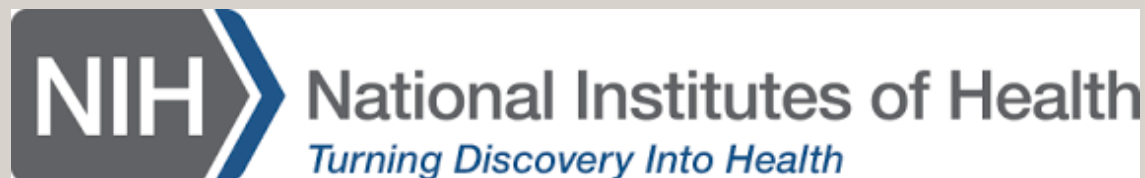
