


Development of Idea



The Project

Introduction

The African Criminal Court is intended to be the first and highest permanent base treaty court established to help bring to justice the perpetrators of the most serious crimes of concern to the continent.

This court is intended as an alternative to the International Criminal Court (ICC) which lacks credibility in many parts of Africa. Similar to the ICC, this court will be specifically established to prosecute perpetrators of genocides, crimes against humanity, and war crimes on the African continent.

Organization on the site

The building is oriented South-North, which means that the access to the site is from the South toward the North, with the entrance of the building facing South. There are two basement floors for personnel parking only, a ground floor, and thirty five floors above ground (total of 38 floors). The parking for the public is on the right front side of the site, just after the entry gate which serves as the vehicle checkpoint. The entrance of the building is within walking distance from the public parking lot. The flags of all African countries will be displayed in a walking gallery between the parking lot and the entrance. The African union flag is located at the entrance to the building.



The jail itself will be developed later in an adjacent building with a secure underground connection.
