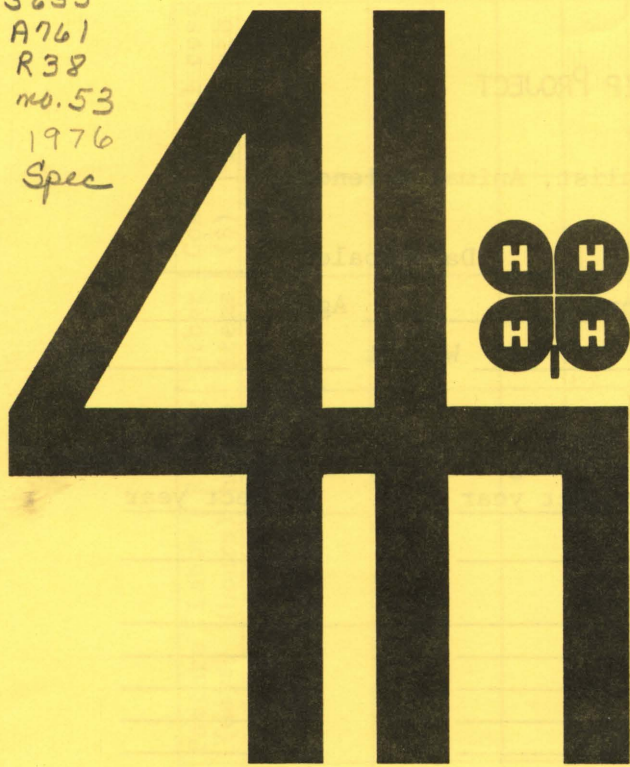


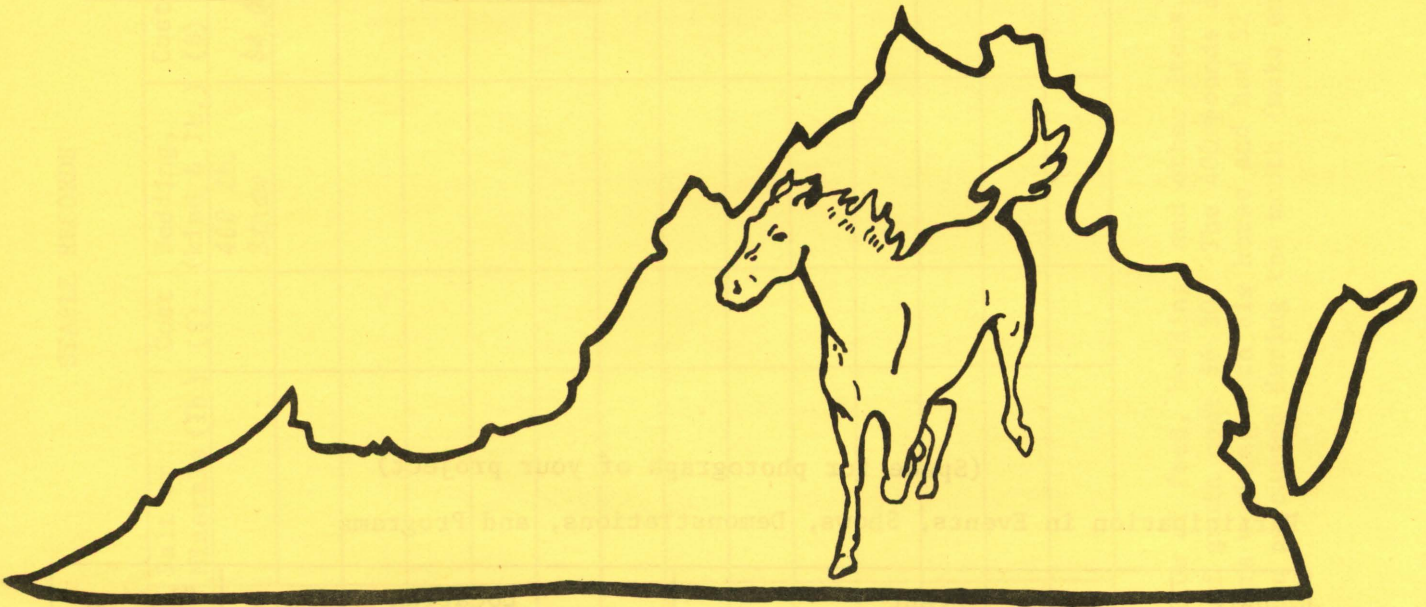

The 400 pounds of straw cost \$4. The horse was not on pasture and the member spent 20 hours working with his horse and had 32 hours of riding time. One brush was purchased for \$1.75. No salt or minerals were purchased during the month (make entry only in month purchased).
