General Guidelines

- Manuscripts are accepted only in English. British English spelling and punctuation are preferred.
- Submitted manuscripts must not have been published as copyrighted material nor be submitted for consideration for publication as copyrighted material while in review by the Journal, whether in print or electronic form. By submitting a manuscript, the author(s) agree that the copyright will be transferred to JEET if the manuscript is accepted for publication.
- The manuscript pages are expected to fall between 15 to 25 pages, including references. Manuscripts that greatly exceed the word limit will be critically reviewed with respect to length. Authors should include a word count with their manuscript.
- Abstracts of 250 words are required for all manuscripts submitted. A concise and factual abstract is required. The abstract should state briefly the purpose of the research, the principal results and major conclusions. An abstract is often presented separately from the article, so it must be able to stand alone.
- Each manuscript should have 2 to 6 keywords, using American spelling and avoiding general and plural terms and multiple concepts (avoid, for example, "and", "of"). Be sparing with abbreviations: only abbreviations firmly established in the field may be eligible.

Submission Guidelines:

- Manuscripts must be submitted in electronic form only at the Journal's Web site: <http://www.journaleet.org/>
- An automatic and immediate e-mail confirmation is provided if the submission process is completed successfully. The Editor subsequently evaluates manuscripts for their compatibility with the Journal's mission and review criteria.
- The Editor typically is able to complete the evaluation and inform the author within two weeks of the submission of the manuscript. The Editor forwards appropriate manuscripts to one of the member of Journal's editorial board, who handles the peer review.
- The Journal is normally able to complete the peer review process and inform the author within one month.

Manuscripts should be compiled in the following order: title page; abstract; keywords; main text; acknowledgements; references; appendices (as appropriate); table(s) with caption(s) (on individual pages); figure caption(s) (as a list).

- **Title Page :**

The manuscript should have a title page which includes :

The name(s) of the author(s)

The Title of the Manuscript

The affiliation(s) and the address(es) of the author(s)

The e-mail address, contact number of the corresponding author

- **Font :** Times new Roman , size 10 for abstract , 12 for text and headings (bold) and 14 for title of the manuscript.
- Abbreviations should be defined at the first place of mention and used thereafter
- Footnotes can be used to give additional information
- Acknowledgements of people , funds / grants received should be place separately preferably after references.
- Internationally accepted signs and symbols should be used
- All figures and tables should be properly numbered and aligned within the manuscript. The source of the table /figure should be mentioned below (in italics , if any)
- Lengthy proofs / derivations should be avoided .If necessary, then should be appended to the manuscript.

Referencing Style:

Citation in text

Please ensure that every reference cited in the text is also present in the reference list (and vice versa). Any references cited in the abstract must be given in full. Unpublished results and personal communications are not recommended in the reference list, but may be mentioned in the text. If these references are included in the reference list they should follow the standard reference style of the journal and should include a substitution of the publication date with either 'Unpublished results' or 'Personal communication'. Citation of a reference as 'in press' implies that the item has been accepted for publication. Indicate references by KM adoption in SC (Patil and Khat, 2009), KM adoption in SC (Patil et al., 2009)

Web references

As a minimum, the full URL should be given and the date when the reference was last accessed. Any further information, if known (DOI, author names, dates, reference to a source publication, etc.), should also be given. Web references can be listed separately (e.g., after the reference list) under a different heading if desired, or can be included in the reference list.

Please ensure that the words 'this issue' are added to any references in the list (and any citations in the text) to other articles in the same Special Issue.

Submission checklist

- Further considerations
 - * Manuscript has been 'spell-checked' and 'grammar-checked'
 - * References are in the correct format for this journal
 - * All references mentioned in the Reference list are cited in the text, and vice versa
 - * Permission has been obtained for use of copyrighted material from other sources (including the Web)
 - * Color figures are clearly marked as being intended for color reproduction on the Web (free of charge) and in print, or to be reproduced in color on the Web (free of charge) and in black-and-white in print
 - * If only color on the Web is required, black-and-white versions of the figures are also supplied for printing purposes

After Acceptance:

- The article will be processed and the author will receive the proofs.
- Authors will be asked to transfer copyright of the article to the RIT.
- Online publication of color illustrations is free of charge. If the author desires color in the print version, he will be expected to pay for extra costs.
