COVID-19 Research Grants on Education and Inequity

The Spencer Foundation is interested in **supporting studies that aim to understand and disrupt the reproduction and deepening of educational inequality caused by the COVID-19 crisis as well as studies that explore ways to remake and imagine anew forms of equitable education.** The program does not specify research topics, disciplines, designs, methods, or locations. Applications will be accepted on a rolling basis with budgets up to \$50,000 for projects ranging from one to three years. Review of applications will take place on May 18th, and again on June 8th. 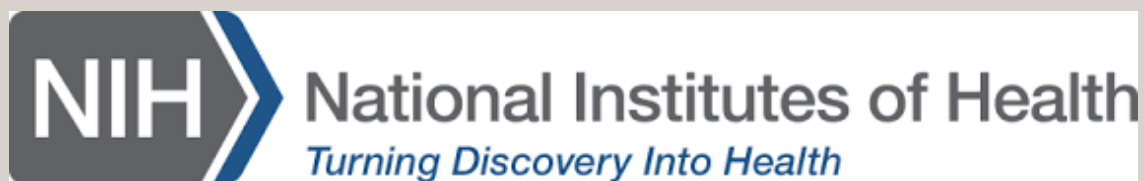

COVID-19 USDA AFRI Opportunity

The Agriculture and Food Research Initiative (AFRI) is America's flagship competitive grants program that provides funding for fundamental and applied research, education, and extension projects in the food and agricultural sciences. 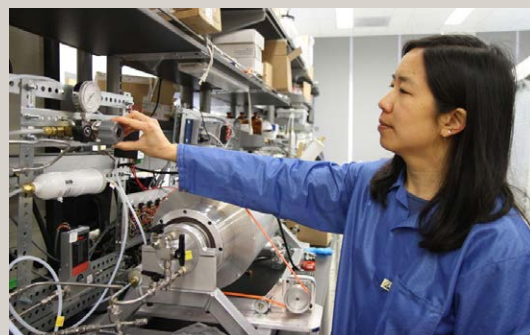


New Network to Connect Decision-Makers with Social Scientists
