- Peer review




WHY BOTHER WITH OA eBOOKS?

- Budgetary constraints
- Physical space
- New initiatives
- Taxpayer funded research
- OA eBooks find their way into expensive packages and approval plans
- Gov Docs
- Alignment with library OA advocacy
- Textbooks



DISCOVERING OA eBooks

- Many online indexes
- None comprehensive
- Some don't provide publisher lists
- Some offer metadata or records
- Some indexed in discovery services



 - to indicate whether it publishes OA monographs, textbooks, novels, or other kinds of OA books

history

- to indicate whether the OA books are also offered in priced, printed editions, perhaps print-on-demand (POD) editions
- to indicate when it launched its (different lines of) OA books
- to indicate the licensing terms on its OA books
- to use deep links to the relevant parts of its portfolio (i.e. its OA line of books or its different lines of OA books)
- (If you don't have some of this information, add the entry anyway. Different users can add different details over time.)

Can You Spare a Little Change? Open Access on the Local Level

It's open access week, and this always is a week when I feel inadequate. I didn't plan ahead. I didn't get that project off the ground, or bring in a speaker. We could invited a contender! I tell myself it's a busy time of year, and my cynical self says "yeah? When isn't it?" and that shuts me right up.

But because I believe in open access, I thought I'd think about the ways small institutions, ones that are understaffed and overworked and underfunded (does this sound familiar?) can make change on a small scale. Here are some things we've been working on at the Little College on the Prairie:

Selecting and cataloging open access books. We don't have a huge demand for ebooks from our community members, and that's good, because it matches perfectly with our lack of money for them. But I've been keeping an eye on the development of open access books. I have personally pitched some spare change at books up for ungluing at Unglue It. It sure felt good when Ruth Finnegan's Oral Literature in Africa was set free. Now five more are up for liberation, and I made my small contribution toward Lauren Pressley's So You Want to Be a Librarian, because a lot of our students are thinking about this profession of mine. I have been looking at OAPEN and the Directory of Open Access Books and projects such as the Australian National University Press and Digital Culture Books and have been selecting books for our collection, which our cataloger has patiently added. Where a print version is available, we have included a note inviting library users to request that we add a print copy; if that's what they prefer, we're happy to make that purchase, and if it adds some change in the pockets of these public-spirited publishing efforts, it's all good.

Methods for Enabling Open Access Content

OCLC WorldShare Management Services, WorldCat Local, and WorldCat Local "quick start" Libraries

There are three easy methods to enable open access content. You can:

- <u>Enable knowledge base links from all open access collections</u> to appear in both the brief search results
 page and item-level detailed records.
- <u>Search for and add knowledge base links from specific open access collections.</u> Links will appear in both the brief search results page and item-level detailed records.
- <u>Display links from Master WorldCat Record 856 and 956 fields to open access/free content</u> (WorldCat Local & WorldShare Management Services Libraries only)

Instructions for and advantages of each method are below. There is little risk to enabling open access content. You can easily disable the features if you do not like the results.


Enable links from all open access collections

How to:

- 1. Go to OCLC Service Configuration WorldCat knowledge base Settings.
- Find the Open Access in Resolver setting. Check the box "journals" and/or "ebooks":

Open access textbooks

- Service to students
- Tag with department/course number in catalog
- Faculty awareness
 - Use in course
 - Develop their own (+ print on demand)

OA publishing by libraries

- Scholarly books (Michigan)
- Textbooks (Temple, UMass Amherst)
- Print on demand income
- Increase awareness of open access
- Support for the humanities



Downsides?

- OA books revert to paid access
- URL stability
- Out of copyright vs. currently issued
- Lack of library-publisher relationship
- Time-consuming for bibliographers
- Faster disintermediation of libraries



The impact of OA on libraries

Three recent surveys (SAGE, InTech, Swets)

Findings:

- Generally not concerned about impact on libraries
- Continued shift from collections to services
- Importance of discoverability
- Managing metadata in semantic web context
- Communication about OA with researchers



Implications

- Less need for collection development/cataloging/etc.
 New roles with refocusing of library services
- Funding shifts/loss
- Scale means
 - Network-level metadata
 - More automation
 - More dependence on publisher metadata
 - Integration of library metadata and SEO
- Improve metadata at the network level?
- More metadata needed identification, licensing, downloadable, textbook level
- PDF and licensing



Future Research

- Current licensing practices for OA e-books
 - and relationship to print on demand
- Do e-books drive print usage in libraries?
 - or trigger print purchases?
- Metadata comparisons
- Will OA drive open metadata?
 - and in turn drive linked data
