The following is an email to state employees sent on Aug. 25. With the November 8 Presidential Election less than 80 days away, my administration is working to ensure that it runs as smoothly as possible. One way to do so is to sufficiently staff all of the Commonwealth's voting precincts with Officers of Election. Officers of Election are stationed in polling places on Election Day, and have two primary jobs-to help citizens vote and to make sure all votes are properly counted. Specific duties include opening the polls to voters, checking voter identification to ensure voters are eligible, offering assistance to any voter who requests it, and obtaining the count of votes from the voting equipment and reporting the results to the Electoral Board, Officers of Election are paid both for attending the required training before the election and for working on Election Day. Payment varies from locality to locality. Officers of Election must be registered voters in the Commonwealth.

Since 2008, state employees have been encouraged to volunteer to serve as Officers of Election. Turnout is projected to be high this year, and many localities have already expressed the need for additional poll workers. For example, Hopewell City needs 10 more. Petersburg City is in need of 50. Richmond City needs an additional 200. Prince William County needs as many as 400 more.

Working with your supervisor to determine work scheduling needs is an important first step, but please note that DHRM Policy 4.05 (http://web1.dhrm.virginia.gov/itech/hrpolicy/pol4_05.html) permits the use of paid Civil and Work Related Leave to serve as an Officer of Election, with approval by your supervisor. Please contact your Human Resource Office for additional information. Virginia Tech Police provide update on recent cyber threat

The following update to the Virginia Tech community is from Virginia Tech Police Chief Kevin Foust:

The Virginia Tech Police Department has an ongoing active investigation under way and appreciates the assistance and

cooperation from the campus community.

At this point we have learned other schools have also received cyber-threats today. The safety of campus is a primary concern, and with this in mind, we remain vigilant in our investigation. Campus is open and operating under normal conditions; classes are in session.

The Virginia Tech Police Department is working with our state and federal partners. We continue to ask anyone with any information about this cyber-threat to contact us at threatassessment@vt.edu or call 540-382-4343.

At this time, the Virginia Tech Police Department can confirm that an email was sent to dozens of emails addresses within our campus community that included a threat to campus safety.

The Virginia Tech Police Department takes all such incidents seriously and are actively investigating.

Parking information for Sept. 3 football game

To accommodate the increase volume of vehicular traffic on campus, the following parking and traffic changes will be in place for the Sept. 3 home football game. Vehicles must be removed from these lots and roads or are subject to being towed.

Commuter, graduate, and resident student vehicles parked along the outside perimeter of the Duck Pond Road Lot (the cage) must berelocated by 5 p.m. All resident student vehicles must be removed from the Stadium and Chicken Hill Parking lots by 10 p.m.

Virginia Tech, Carilion Clinic partnership, athletics facilities improvements highlight board of visitors meeting

Leaders from Virginia Tech and Carilion Clinic met Sunday and today to discuss with members of the Virginia Tech Board of Visitors the growing partnership between the two organizations and the expanding university footprint in Roanoke to serve the region and the commonwealth.

On Sunday, the board learned more details of the partners' vision for the Virginia Tech Carilion Health Sciences and Technology Campus in the Roanoke Innovation Corridor. And today, the board in turn passed a key resolution—an important next step— and voted to support an effort to fully integrate the academic and research missions of the Virginia Tech Carilion School of Medicine into Virginia Tech.

The integration process will take approximately two years to complete and it will result in the establishment of a ninth college at Virginia Tech. A full story on this is found at

In other news, board members also approved resolutions for the demolition of Monteith and Thomas halls. The two residence halls, currently used for Corps of Cadet housing, will be unoccupied following the completion of a second new residence, which is all part of the plan to upgrade and improve the Upper Quad.

The board also approved several facility improvement projects in support of intercollegiate athletics

(http://vtnews.vt.edu/articles/2016/08/bov-athletics.html). Those projects include a complete reconstruction of the school's baseball facility, English Field at Union Park. Also included is a new hitting facility for the softball team and major enhancements and additions to Rector Field House, which will benefit not only the track and field programs, but also the lacrosse, soccer and softball teams.

Individual stories on these projects will run in Virginia Tech News starting Aug. 30.

The Academic Affairs Committee received updates on the new undergraduate degree programs in computational modeling and data analytics and neuroscience.

On Sunday, Theresa Meyer, vice president for research and innovation, spoke to the Research Committee on Virginia Tech's global research profile, presenting data and information on how university's research activities compare to research universities around the world.

The board recognized Professor Emeritus John Hosner with the additional tribute of "honorary founding dean" of the College of Natural Resources and Environment for his role in the establishment of the

college as it marks its 25th anniversary.

In addition, eight individuals were honored with emerita or emeritus status, and seven faculty members received endowed professorships, fellowships, or chairs. Stories on each person will appear in Virginia Tech News (www.vtnews.vt.edu) beginning Wednesday, Aug 31.
