## Appendix D: Case Study Focus Group Survey

#### **Focus Group Survey Sheet:**

Script – to be read orally to participants

"I am trying to gather information about how residents lives and perspectives may have changed since moving into Cohousing. For each question please mark whether you believe that you are much less, somewhat less, the same amount, somewhat more or much more likely to do or to believe the various things I will be asking. For the sake of clarity it is best to think about comparing your actions and perspectives in the years just prior to involvement with Cohousing against the years since move-in."

For example: If I say "How well you feel you know your neighbors". I am asking you to compare how well you know your neighbors now vs. how well you knew them where you lived just prior to your involvement in Cohousing. Do you feel you know your neighbors much less now? Somewhat less? The same amount? Somewhat more? Or Much more?" We will pause after every five questions to make sure everyone is caught up and to address any need for clarification.

- 1. Number of people you converse with in the course of a typical week.
- 2. How well you feel you know your neighbors.
- 3. Number of people, outside your immediate family who know you well.
- 4. Number of people in whom you feel you can confide.
- 5. How much you trust your neighbors.
