Annual Report Executive Summary, 2006-07 Department of Psychology

Learning: Undergraduate

- We continued to offer a range of courses to serve our 900+ majors, along with seven Area 3 core courses serving the broader university.
- More than 130 undergraduates were enrolled in field study and undergraduate research credits and participated in community and research opportunities.
- Tamer Desouky, a graduating senior, was named the 2007 Outstanding Psychology Senior.
- Six psychology majors received 2007 Research Awards: Tamer Desouky, Corey Detrick, Christina Goodwin, Michelle Patriquin, Sara Williams, and Heather Wright.
- Ryan Clark and Kecia Foster received Department Awards for Outstanding Service.
- Roseanne Foti received the Society of Industrial and Organizational Psychology (SIOP) Distinguished Teaching Award
- David Harrison received the Alumni Students' Choice for "Favorite Professor Award" sponsored by the Student Alumni Association at Virginia Tech
- Kurt Hoffman was awarded a Certificate of Teaching Excellence and was inducted into the University Academy of Teaching Excellence

Learning: Graduate

- The Clinical, Industrial/Organizational, and Developmental and Biological Psychology doctoral programs had 76 graduate students.
- Sixteen new graduate students accepted admission offers for August 2007. They had impressive qualifications (Median GPA=3.7, GRE-V=585, GRE-Q=630).
- Seven students received the M.S. and ten students received the Ph.D during 2006-07.
- Six students received clinical internships at highly selective research institutions.
- Five graduate students received GRDP Research Awards, ranging from \$150–\$375.
- Michael Knepp received the College of Science Roundtable Scholarship for Graduate Study, \$1000
- Philip Lehman received the Graduate Teaching Assistant Excellence Award for 2006-2007.

Discovery

- The faculty and graduate students were authors on 46 peer-reviewed journal articles published in 2006 with another 49 articles in press at the end of the 2006.
- They also published 24 book chapters with another 36 chapters in press and were authors on numerous other published abstracts, technical reports, and brief research reports.
- Nine faculty had active grants or contracts during FY07 with over \$2.7 million in research awards.
- Two research faculty were supported on grants and two postdoctoral associates joined the faculty in 2006-07.
- The Department sponsored or co-sponsored 16 colloquia and workshops given by national and international scholars.
- Matthew Fritz was successfully recruited as an Assistant Professor with a specialty in developmental methodology to begin in 2007-08.

Engagement

- Russell Jones was nominated for a University Outreach Award for his work in the aftermath of Hurricane Katrina.
- Ryan Clark and Kecia Foster, undergraduate psychology majors, received Department awards for outstanding service for their many hours of volunteer work with various local and national agencies.
- The Psychological Services Center and Child Study Center provided psychological services to over 100 local community residents.
- Faculty were editors or associate editors of 11 peer-reviewed journals and were on editorial boards of 16 other journals.

Diversity

- Four faculty were involved in AdvanceVT workshops or programs designed to foster and support women in academic positions.
- At least nine faculty are actively involved in McNair, MAOP, and VTPREP programs to
 promote the recruitment and success of minority students at both the graduate and
 undergraduate levels.
- The Department supports a chapter of the Association of Black Psychologists.
- Two faculty traveled to predominantly black universities or professional association meetings to give talks promoting our graduate programs.
- Three faculty sit on College of Science or University Committees promoting diversity in the students and faculty.
- Successfully recruited five new graduate students for 2007-08 from underrepresented racial and ethnic groups.

Goals for 2007-08

- Improve the consistency of undergraduate education by restructuring the faculty and graduate student teaching responsibilities for 4000-level lectures and laboratory classes.
- Improve graduate student core training in research methods and statistics by expanding our research methods class to two semesters.
- Increase grant submissions and research productivity through selected faculty participation in grant writing workshops and teaching load reductions.
- Continue active outreach and efforts to increase diversity in all areas of the Department.

INTER-AREA FACULTY

FIVE-YEAR REVIEW COMMITTEE

The College of Science will address departmental reviews and schedule the next Psychology review. The internal review committee will also assist in identifying external reviewers, who will be invited by the Dean to conduct the external review of the department when the review is scheduled. DEPARTMENTAL EXECUTIVE COMMITTEE

This committee will serve to advise the Chair in matters regarding the goals and objectives of the department. The committee will consist of six or more persons, including the Chair of the Department who will chair the committee, and the Associate Department Chair, who will serve ex officio and will assume the Committee Chair when the Department Chair is absent. The other members will be the Director of Graduate Programs, the Director of Undergraduate Studies, and representatives elected by the faculty. Note: For graduate program representation, the top vote-getter from each graduate program will be appointed. During fall 2004, faculty members voted that elected Executive Committee members will serve a two-year term, and the term will be based on calendar years. Elections were last held in December 2006 for the calendar years 2007 and 2008. The next election will be for a term that begins in January 2009.

PERSONNEL COMMITTEE

The 2005-06 Departmental Personnel Committee conducts the departmental review for promotion and tenure in accordance with the procedures described in the <u>Faculty Handbook</u>, which indicates that the departmental committee shall consist of the Department Chair and an appropriate faculty representation. For purposes of tenure recommendations, the Personnel Committee in the Department of Psychology shall consist of the Department Chair plus six other tenured faculty members; three elected by the full-time faculty and three appointed by the Department Chair after the election. Additional members may be appointed by the Department Chair to represent specialty areas for any year in which promotion or tenure is being considered. The committee composition will be announced in a manner which disregards the elected or appointed status of its membership. Based on faculty discussion and vote, and, consistent with the College of Sciences' Promotion and Tenure Committee, the "peel-off-by-rank" system will no longer

be used for promotion to Professor. The Department Chair and the Personnel Committee may choose to meet with Professors to discuss promotion considerations for candidates being considered for promotion to Professor.

The Departmental Personnel Committee shall be responsible for making recommendations for any new faculty appointments that will involve an entering tenure appointment and/or rank above assistant professor. The Departmental Personnel Committee will also be responsible for providing the Department Chair with an assessment of the degree to which the committee feels that each faculty member (below the rank of Professor) is progressing satisfactorily within rank. This is not to be confused with the assessment that the Annual Review Committee makes of the annual Faculty Activities Reports by the faculty. The former involves a review of the entire career of a faculty member, while the latter is an assessment of the productivity for one year. Both assessments will be shared with the faculty member at the time that the Department Chair provides the annual performance evaluation. The PROMOTE process was implemented by the Personnel Committee during 1998-99, and will be continued during the current academic year. The PROMOTE process is available in a separate document. The Personnel Committee also serves as the department's Post-tenure Review Committee, should a post-tenure review be required consistent with department and university policy.

During fall 2004, faculty members voted that Personnel Committee members will serve a two-year term, and the term will be based on calendar years. The last elections were held in December 2006 for the calendar years 2007 and 2008. The next election will be for a term that begins in January 2009.

ANNUAL REVIEW COMMITTEE

The Department established the Annual Review Committee during spring 1998. Three full professors are elected to review the FARs of all faculty members and provide comments and ratings. These ratings and comments are advisory comments to the Department Chair, who will convey the information along with the Department Chair's rating and comments. Only the Department Chair's ratings and comments will be forwarded to the Dean for the annual review. Because the Personnel Committee serves as the Department's PTR Committee, full professors who are members of the Personnel Committee may not serve on the Annual Review Committee. The election plan approved at the Spring 1998 faculty meeting was to alternate the highest ranked full professors across the Annual Evaluation Committee and Personnel Committee. This plan was followed in constituting this year's committees.

DIRECTOR OF GRADUATE PROGRAMS

Dr. Deater-Deckard will be responsible for coordinating the graduate programs so that there is uniformity with regard to the meeting of University and Department requirements. In this capacity, he will serve as Chair of the Graduate Admissions and Support Committee and also as Chair of the Core Curriculum Committee.

CORE CURRICULUM COMMITTEE

The committee will also consider proposals for new graduate courses (both within and outside of the core curriculum). It will be required to meet a minimum of at least once each semester and will work closely with the Director of Graduate Programs.

GRADUATE ADMISSIONS AND SUPPORT COMMITTEE

This committee also will coordinate offers of graduate assistantships to incoming students. The graduate admissions procedure will be as follows:

- 1. As applications are received from the Graduate School, they will be logged into a data-based computer file and will be placed in a separate folder kept in a central location.
- 2. It will be the responsibility of each area representative to insure that the folders for each area are available to the faculty and are not misplaced.
- 3. Program faculty will rate the appropriateness of each applicant and the Director of each program will submit requests to admit candidates to the Director of Graduate Programs based on the ratings.
- 4. The Director of Graduate Programs will make a recommendation regarding admission to the Department Chair.

GRADUATE STUDENT COMMITTEE FOR LIAISON WITH THE DIRECTOR OF GRADUATE PROGRAMS

It is the responsibility of this Committee to provide a formal, effective, and meaningful vehicle for graduate student input.
