Defining the "Open" in Open Content

"Open content" is content that is licensed in a manner that provides users with the right to make more kinds of uses than those normally permitted under the law. These permissions are granted to users free of charge.

The primary permissions or usage rights open content is concerned with are expressed in the "5Rs Framework:"

1. Retain - the right to make, own, and control copies of the content (e.g., download, duplicate, store, and manage)
2. Reuse - the right to use the content in a wide range of ways (e.g., in a class, in a study group, on a website, in a video)
3. Revise - the right to adapt, adjust, modify, or alter the content itself (e.g., translate the content into another language)
4. Remix - the right to combine the original or revised content with other open content to create something new (e.g., incorporate the content into a mashup)
5. Redistribute - the right to share copies of the original content, your revisions, or your remixes with others (e.g., give a copy of the content to a friend)

Content is open to the extent that its license allows users to engage in the 5R activities. Content is less open to the extent that its license places restrictions (e.g., forbidding derivatives or prohibiting commercial use) or requirements (e.g., mandating that derivatives adopt a certain license or demanding attribution to the original author) on a user's ability to engage in the 5R activities.

Philosophy of the GNU Project

Free software means that the software's users have freedom. (The issue is not about price.) We developed the GNU operating system so that users can have freedom in their computing.

Specifically, free software means users have the [four essential freedoms](#): (0) to run the program, (1) to study and change the program in source code form, (2) to redistribute exact copies, and (3) to distribute modified versions.

Software differs from material objects—such as chairs, sandwiches, and gasoline—in that it can be copied and changed much more easily. These facilities are why software is useful; we believe a program's users should be free to take advantage of them, not solely its developer.
