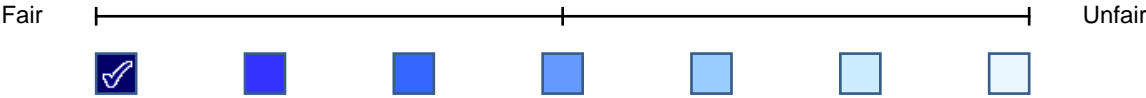

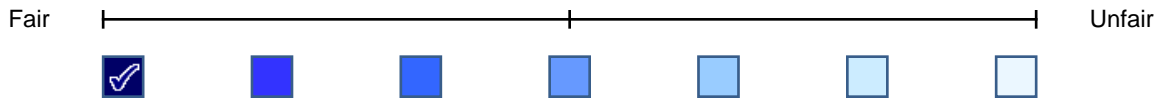

Images are used to relay information from public and free EPA documents to help readers understand the regulations as background for the thesis work.



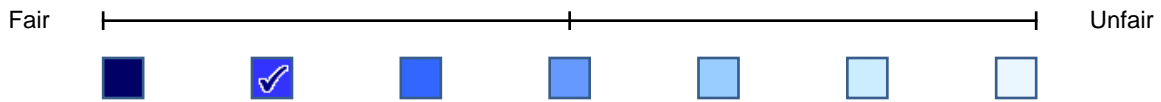

The work is created by the federal government and is part of freely available public documentation of regulations.



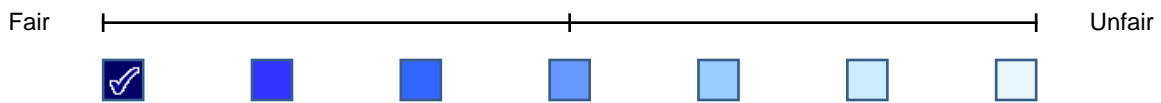

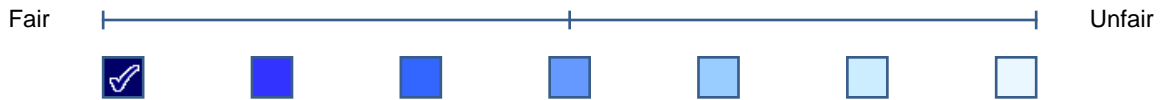
