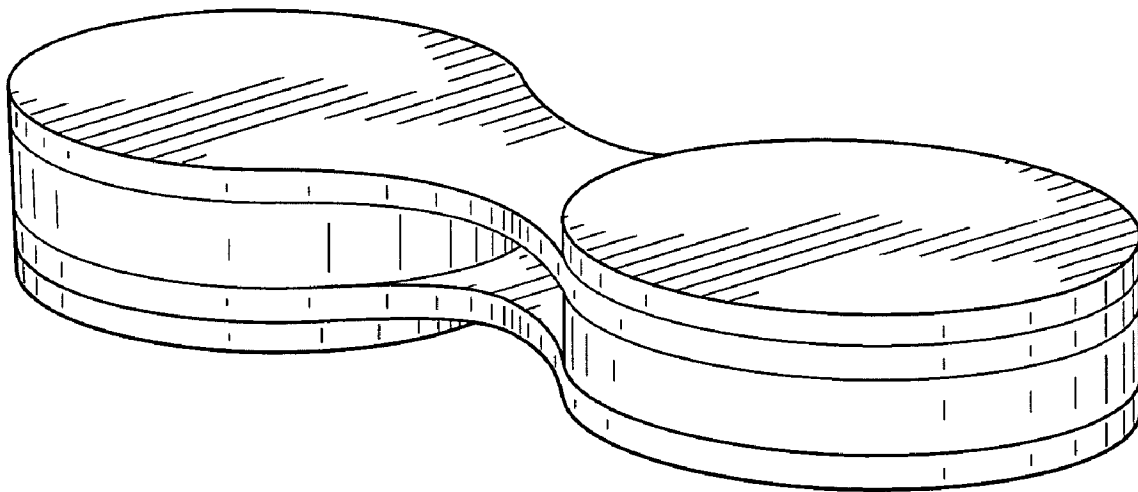
FIG. 8 is a perspective view of a set of interconnecting tessellated game tiles of FIG. 1.

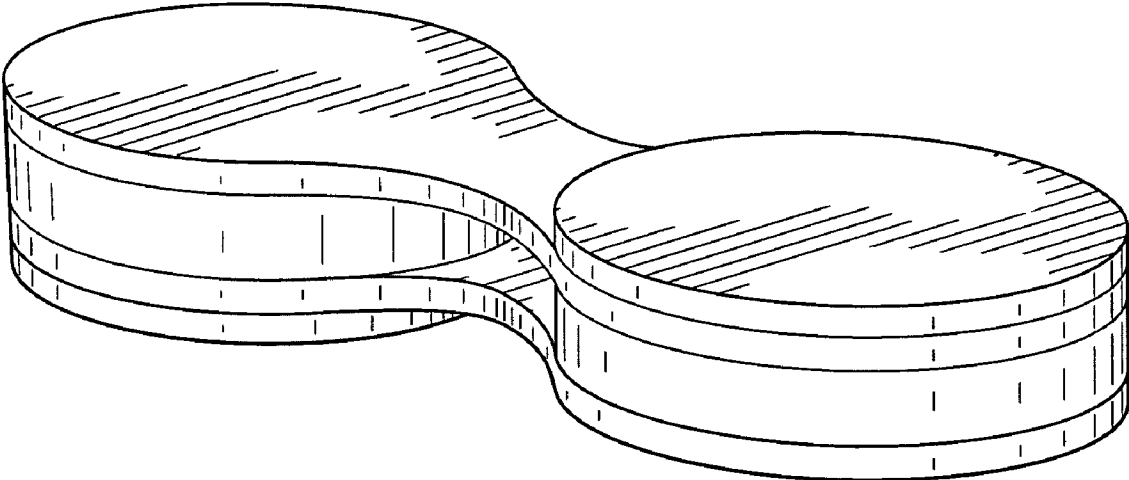

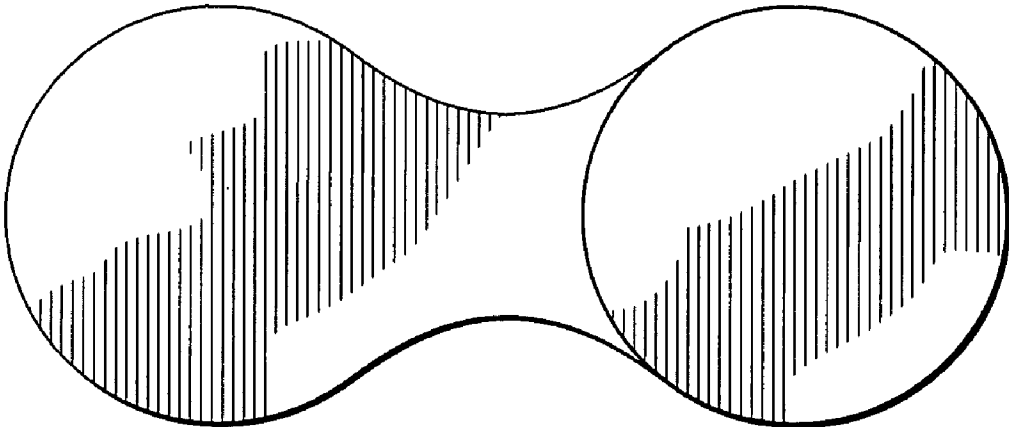

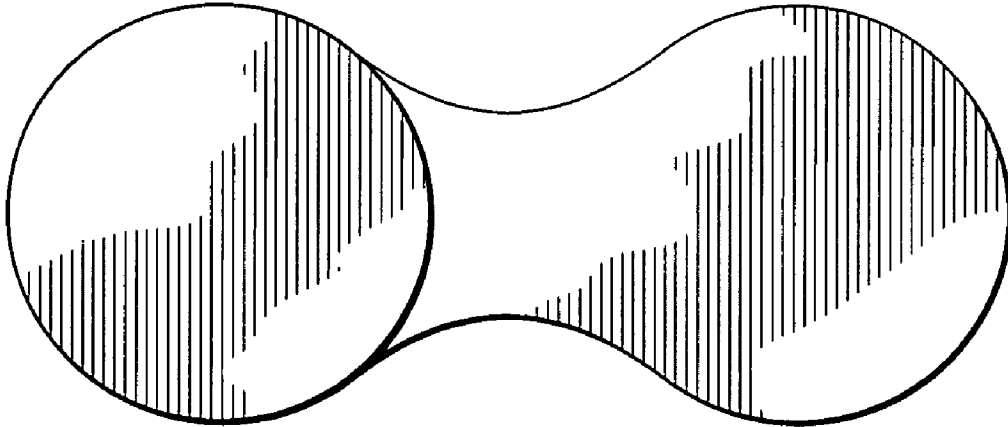

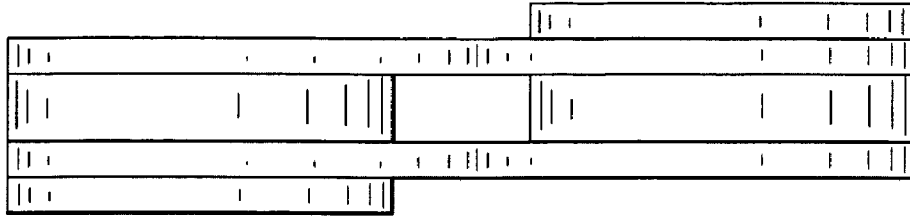

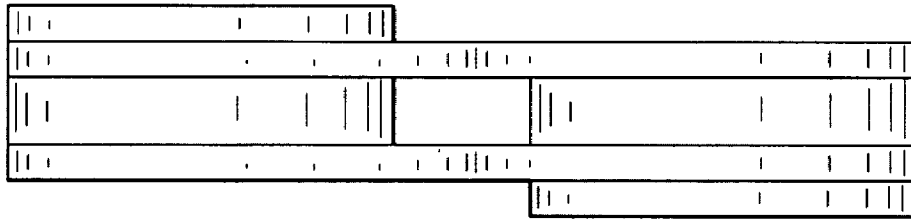

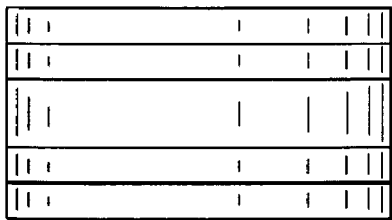

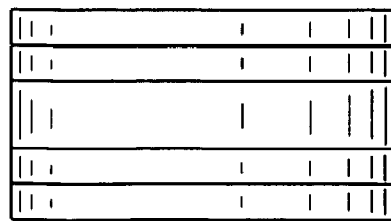

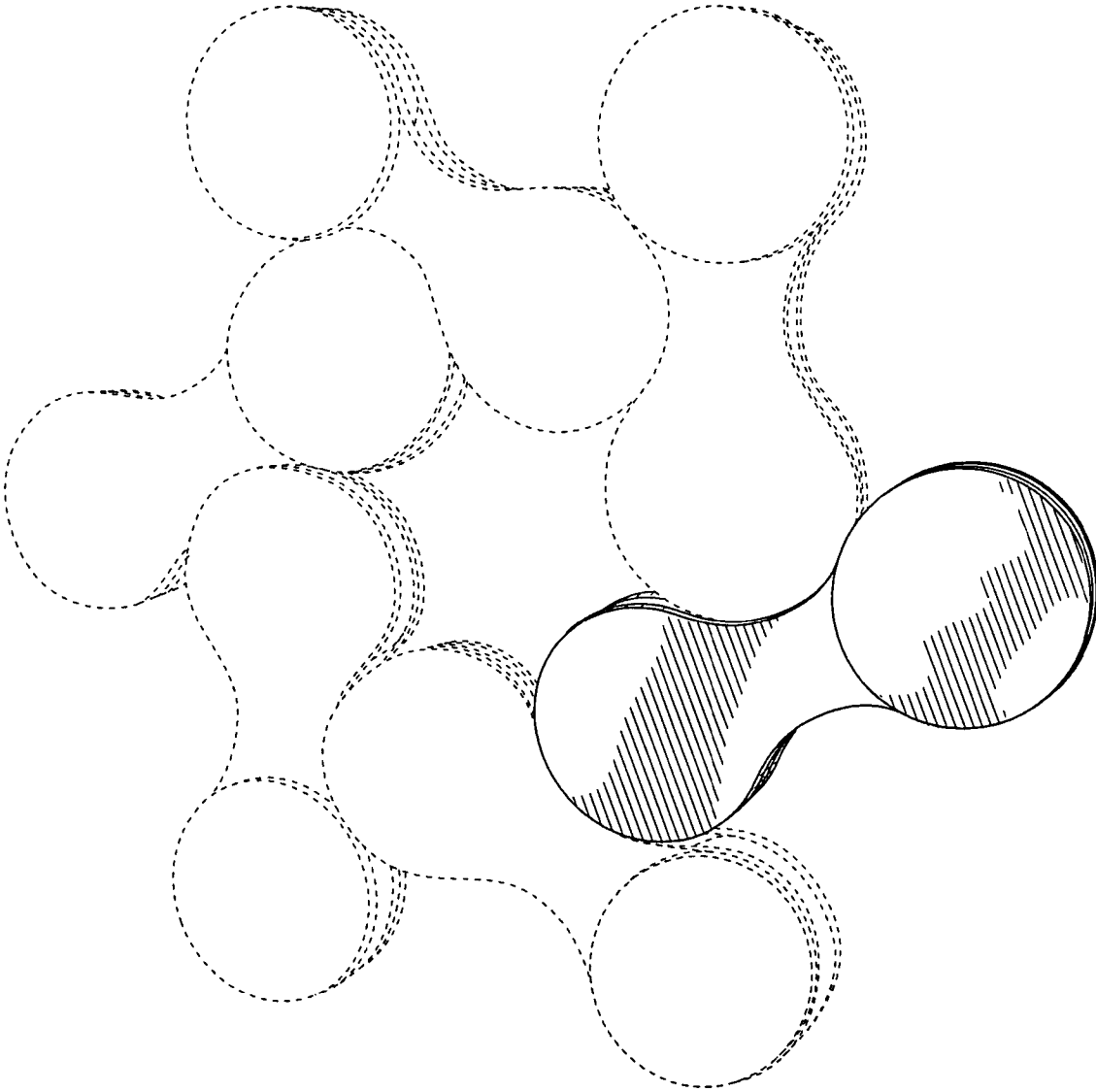
