Author Responsibilities

Submissions that are relevant to the OCEANS program are welcome. All papers are subjected to a stringent review procedure directed by the conference organizers. It is the responsibility of the authors, not MTS, to determine whether disclosure of their material requires the prior consent of other parties and, if so, to obtain it. Authors are solely responsible for obtaining permission to use drawings, photographs, tables, lengthy quotations (300 to 500 cumulative words or more from one source) and other previously published material. A copy of the statement from the copyright owner granting permission must be sent to the managing editor prior to galley proofs being returned for approval.
